As additional time is required by the Vendor and the Vendor Guarantor for the fulfillment of certain Conditions, the Vendor and the Purchaser have therefore agreed in writing to further extend the Long Stop Date for the fulfillment of the Conditions from 30 September 2020 to 31 March 2021 or such other date as the Vendor and the Purchaser may agree in writing.
